EMERGENT CIRCULAR FOR ALL CONCERNED REGARDING OPENING OF SEALED PACKETS OF QUESTION PAPERS OF D El Ed PART-I EXAMINATION-2017-19

In partial modification of our guidelines and instructions under Clause-d (on Page-2), in the Memo No.134 (250)/BPE/D El Ed/2019, dated 03.06.2019, this is to notify for all concerned as under:

The sealed packets of question papers, received from the custodian, shall only be opened in one of the **Examination Halls** in presence of the Officer in Charge, Centre Superintendent, invigilator & Examinees of that **hall** just **15 (fifteen)** minutes before the commencement of the Examination each day, i.e. not before 11:45 a.m.

During the period from 11:45 a.m. to 12:45 p.m. no-body will be allowed to leave the examination hall.

Any deviation or violation of the said instruction will lead to cancellation of the examination as well as severe punishment of the person of that Venue, responsible.

The respective district police administrations has also been requested to keep strict vigil over such affairs and to take steps accordingly.

Also, it is to be ensured that nobody in the hall does have his or her mobile phone in any condition.
